## Key Responsibilities

- Support the UK Public Affairs team in managing UK Finance's interests in relevant legislation before the UK Parliament.
- Monitor, and draft summaries of relevant parliamentary sessions, including select committees and debates in both the Commons and the Lords as required.
- Support colleagues across the organisation in their advocacy work.
- Support the planning of parliamentary events and engagement activities at party conference.
